**1. Call to Order**

Mr. Bublat called the meeting to order at 6:31pm.

**2. Agenda Review**

A motion was made to table items 7 and 8 until Brian returns, with all agreeing to table without a formal motion. Discussion ensued about whether to talk about the Development Review Board, leading to a decision to discuss what could be discussed and add new items to the agenda as item 10, moving other items down.

**3. Comments from the Chair and Land Use Administrator**

The Chair expressed concern over not being included in the agenda preparation and requested that the agendas be prepared and shared earlier. The Land Use Administrator updated on upcoming hearings and clarified the board composition and appointments, especially concerning Howard's status. There was a discussion on the necessity of reappointing Howard to the Planning Commission due to administrative oversight.

**4. Comment from citizens regarding items not on the agenda**

The discussion touched upon Howard's membership status, the importance of confirming appointments, and the need for clarity on board members' terms.

**5. Approval of Meeting Minutes: December 11, 2023 & February 12, 2024**

It was decided to table the approval of December 12, 2023, minutes due to missing information. The February 12, 2024, minutes were approved with amendments suggested for accuracy, particularly naming the correct individuals for motions and correcting the date discrepancy.

Joe was nominated and elected as Chair; Brian was elected as Vice-Chair in absentia, and Hank was reluctantly elected as Clerk.

- **Meeting Minutes**

The discussion about meeting minutes revolved around their format and the efficiency of recording them.

This was tabled earlier in the meeting and discussed briefly regarding the necessity of having discussions even if decisions were not immediately forthcoming.

## **8. PUD Review Continued Discussion**

This item was tabled during the agenda review and moved to be discussed in a future meeting.

Similar to item 8, this topic was also tabled during the agenda review for discussion at a later date.

The letter to the Select Board regarding meeting changes was discussed extensively, debating the impact of changing established meeting schedules on public participation and board members' schedules.
